

## **Pizza Hut Hut Hut Win Sweepstakes & Instant Win Official Rules**

**NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND  
WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. Eligibility:** Pizza Hut Hut Hut Win Sweepstakes & Instant Win (the "Promotion") is open only to legal residents of the fifty (50) United States (including District of Columbia) who are at least thirteen (13) years old and who are members of the Pizza Hut® Hut Rewards® program at the time of entry. Membership in the Pizza Hut® Hut Rewards® program is free but subject to the listed [Program Terms and Conditions](#). Employees of Pizza Hut, LLC ("Sponsor"), its franchisees, Yum! Brands, Inc., TLP, Inc., Roundarch Isobar, Inc. ("Isobar"), PepsiCo, Inc., Pepsi-Cola Company and its bottlers, the NFL Entities (as defined below), and their parent and affiliate companies, suppliers as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Promotion. **3. Timing:** The Promotion begins on September 1, 2019 at 12:00 a.m. Eastern Time ("ET") and ends on December 31, 2019 at 11:59 p.m. ET (the "Entry Phase"). Individuals can make eligible purchases to participate in the Promotion from September 1, 2019 at 12:00 a.m. ET through December 29, 2019 at 11:59 p.m. ET (the "Purchase Phase"). Administrator's computer is the official time-keeping device for this Promotion.

**4. How to Enter:** During the Entry Phase, visit [www.HutHutWin.com](http://www.HutHutWin.com) (the "Website") and follow the links and instructions to register for the Promotion by providing a valid email address associated with your Pizza Hut® Hut Rewards® account. You will receive one (1) Instant Win Game play and one (1) virtual NFL Team game piece (first visit only). Virtual game pieces can be accrued to receive an entry into the Division Sweepstakes drawing and Grand Prize Sweepstakes drawing, as outlined below. After you register, there are two (2) ways to earn additional Instant Win Game plays and additional virtual NFL Team game pieces, as outlined below:

- a. Make a Purchase:** During the Purchase Phase, place a Pizza Hut order using your Hut Rewards account (via the app, via the online website, or via phone). Then, during the Entry Phase, visit the Website and follow the links and instructions to log in. For every \$5 spent on each individual order (excluding tax, tip, gift cards and donations), you will receive one (1) Instant Win Game play and one (1) virtual NFL Team game piece, up to the maximum Instant Win Game plays and virtual NFL Team game piece totals outlined below. Instant Win Game plays and virtual game pieces may take up to 48 hours to appear in your Hut Hut Win dashboard. Any purchase made twenty-four (24) hours prior to registering for the Promotion will count towards Instant Win Game plays and virtual game pieces, so long as such purchase is made during the Purchase Phase. Purchases

are not cumulative during the Purchase Phase, meaning, for example, if you spend \$12 on one order and \$19 on another order, you will receive five (5) total Instant Win Game plays and five (5) total virtual NFL Team game pieces (two (2) Instant Win Game plays and two (2) virtual NFL Team game pieces for the first order and three (3) Instant Win Game plays and three (3) virtual NFL Team game pieces for the second order).

- b. Alternate Method of Entry:** During the Entry Phase, to play without making a purchase, visit <https://www.huthutwin.com/#/oamoe> and follow the links and instructions to log in and complete the “free plays/free NFL team game pieces” request form. You must select whether you would like to receive “free plays” or “free NFL Team game pieces”. You will receive an email with a unique link. During the Entry Phase, click on the link in the email received and follow the instructions to log in. Depending on what you selected, you will either receive four (4) Instant Win Game plays or four (4) virtual NFL team game pieces.

During the Entry Phase, once you receive sixteen (16) NFL Team game pieces on your virtual NFL Team game piece card, you will receive one (1) Sweepstakes entry into the Division Sweepstakes drawing. Once you receive thirty-two (32) total NFL Team game pieces on your virtual NFL Team game piece card, you will receive one (1) Sweepstakes entry into the Grand Prize drawing.

During the Entry Phase, follow the links and instructions to play the Instant Win Game. The Instant Win Game results will be instantly displayed. Potential winners of the Instant Win Game will be immediately provided on-screen directions for winner validation. All potential winners are subject to verification before any prize will be awarded. **5.
